## Liability

I further agree to the performance of treatment, anesthetics, and operations deemed necessary for me in the opinion of the medical personnel present.

I understand that while I participate in any of the River Valley Church sponsored activities, I am responsible to abide by the rules set forth by River Valley Church, its agents, employees, and properly appointed volunteers. Any serious infraction of the rules or conduct can result in dismissal from my trip and removal from all activities associated with the trip. In the case of such a dismissal I, the undersigned, agree to assume the cost of returning to my home. I also agree to forfeit any possible refund.

I understand that River Valley Church is a non-profit organization registered in the State of Minnesota and that due to IRS regulations, all contributions made to the River Valley Church are non-refundable.

## Conduct

As a team member on a River Valley Church sponsored short-term missions trip, I will make every effort to maintain a positive and flexible attitude at all times.
